Plaintiffs and Parties-in-Interest represented by Curtis Thaxter LLC (collectively "Plaintiffs"), by and through counsel, hereby move, pursuant to Rule 52 of the Maine Rules of Civil Procedure for additional findings of fact to support conclusions not addressed by facts found in the court's "Partial Judgement" dated October 16, 2012.

Any party may file a motion to request findings of facts and conclusions of law within (5) days of an entry judgment. M.R. Civ. P. 52(a). "The purpose of motions for findings of additional facts pursuant to M.R.Civ.P. 52(b) is to seek specific fact-finding to support conclusions not already addressed by facts found in the court's opinion." Wandishin v. Wandishin, 2009 ME 73, ¶18. These motions should specify the conclusions that require additional fact findings and should "suggest particular facts to be found that are supported by the record and are relevant to the conclusions at issue." Id. This is because a trial court has a "duty to make findings sufficient to inform the parties of the reasoning underlying its conclusions and to provide for effective appellate review." Jarvis v. Jarvis, 2003 ME 53, ¶22, 821 A.2d 913, 917 (citing Bayley v. Bayley, 602 A.2d 1152, 1153–54 (Me. 1992)).

Prior to closing remarks, this Court requested proposed findings of fact and conclusions of law from each party. Plaintiffs submitted detailed findings of fact and conclusions of law as

to each Plaintiff's property and a post-trial brief prior to closing remarks. On October 16, 2012, this Court entered a Partial Judgement and concluded that the Town and TMF Group had established a public and class prescriptive easement, respectively, over Goose Rocks Beach. This Court recognized that both the Town and TMF Group had the burden to establish the necessary elements of a prescriptive easement as to each Plaintiff's property, but did not make any specific findings of fact with regard to each individual Plaintiff's property. Although Plaintiffs already submitted findings of fact, Plaintiffs respectfully now seek—out of an abundance of caution—additional findings of facts to support this Court's conclusion that the Town and TMF Group satisfied their burden of proving each element of a prescriptive easement as to each of Plaintiff's property pursuant to Rule 52(b).

Specifically, as to each Plaintiff's property, Plaintiffs request findings of fact as to the specific time period in which the Town and the TMF Group's prescriptive claims ripened; the nature, location (dry sand v. intertidal zone); the extent and duration of recreational uses that occurred during the Town or TMF Group's claimed period, and which specific facts mentioned in this Court's Partial Judgment pertain to which of the Plaintiffs' properties and what portion of those properties.
